

IDAHO COUNTY REPUBLICAN CENTRAL COMMITTEE

Meeting Minutes December 16, 2025

The regular monthly meeting of the ICRCC was held at the Super 8 Motel in Grangeville on December 16, 2025. The meeting was called to order at 6:06 p.m. by Chairman Vince Rundhaug.

Roll was taken and 23 members were present (22 in person + 1 on Zoom). We had a quorum.

Youth Coordinator Gabe Pogue led the prayer and the Pledge of Allegiance was recited.

The business agenda was unanimously approved with one addition to New Business. PC Scott Perin will discuss an "Opt Out" resolution.

The minutes of the November 18, 2025 meeting were approved unanimously.

Treasurer Patricia Menough gave a financial report.

Standing Committee Reports

Event Planning Committee Report

Committee Chair Patricia Menough reported she has spoken with Idaho County Auditor Kathy Ackerman regarding the America 250 celebration in Idaho County. Kathy (or her employees) will be going into all of the area schools promoting the celebration; however, ICRCC is not allowed to help with that effort. The ICRCC is allowed to do promotion for the event on our own. Ideas would be to incorporate this into the LDD theme and include information on the ICRCC website.

Special Committee – Zoom Committee

As requested at our November meeting, the Zoom Committee gave Chairman Vince Rundhaug information they gathered on a variety of Owl systems, their features and the costs of each unit. PC Rachel Pogue suggested the committee also look into a Zoom Camera. Before a purchase is made, more information will be presented at the next meeting.

Special Committee – Lincoln Day Dinner Committee

Committee Chair PC Roy Farmer reported the Grangeville Elks Lodge has been confirmed for the event on February 7, 2026. The papers have been signed and insurance for the event will be purchased through the Elks Lodge. More seating will be available this year with the changes the Elks Lodge has made to the dining area. Taste of Art Catering has been confirmed.

PC Corey Koole explained the changes being made for ticket and tables sales in an effort to make the event check-in move more quickly the night of the event. A QR Code system will be implemented allowing tickets to be scanned at the door. Corey is working on organizing the table sales. He handed out a flyer with the details for the committee.

Committee Vice Chair PC Scott Perrin reported Josh Crosby has a scheduling conflict and will not be available to attend. Scott contacted Wendy Lindsley and she will be providing musical entertainment this year.

All PCs are asked to sell at least 6 tickets to the event. PCs are also asked gather 5 auction item donations from their respective area businesses by January 15th. PC Bruce Walker at Walker's Jewelry in Grangeville is the drop off location for auction items. Each auction item should also have a donation sheet attached. This sheet provides all of the information needed to comply with the Secretary of State regulations and it also ensures our donors are given proper recognition for their contributions.

Local Elected Officials and Other Reports

Idaho County Sheriff

Sheriff Doug Ulmer reported the new jail is in the final stages of construction. Desks are being placed and the final electrical work is being completed. The department will be replacing their side by side UTV that was recently damaged in Elk City during an arrest. The SRS funding has been reallocated for 2026 and has been retroactively allocated for 2023, 2024 and 2025. Search and rescue victims are not billed in Idaho County and this funding makes search and rescue efforts possible in Idaho County.

Winter GOP Meeting Stipend
